





MOLLY A. HIRST

Ph.D. candidate in the Department of Ecology and Evolutionary Biology at the University of Michigan, Ann Arbor

Years at Schoolcraft: 2009-2011

Course of study: Liberal Arts; Associate in Science in 2012

"I am incredibly grateful for all the experiences that I had at Schoolcraft College, which ultimately led me to where I am today." Attending Schoolcraft College started Molly A. Hirst on a path that has led her to becoming a Ph.D. candidate at one of the most prestigious universities in the world.

Pretty impressive for someone who was a first-generation college student originally in pre-nursing. Taking Professor Caroline McNutt's introductory biology course literally changed her career track.

"The enjoyment that I found in learning at Schoolcraft College was what allowed me to transform my career goals into pursuing higher education," she said.

Hirst transferred to the University of Michigan-Dearborn in 2011, then transferred credits back to Schoolcraft to earn her Associate in Science in 2012.

"Growing up, becoming a scientist was something that I thought would be a fun and exciting career path, but I had never imagined that it would be possible for a low-income, first-generation woman like myself," she said.

Hirst's hard work and support and mentoring from professors like Caroline McNutt have helped bring that dream into focus. She hopes to finish her doctoral dissertation by April 2022.

Along the way, she is making an impact on students – just as Professor McNutt did with her.

"As a graduate student instructor at the University of Michigan, I have seen some of my students become inspired by learning more in-depth biological concepts and phenomenon," Hirst said. "Some of my students have even changed their career paths to pursue higher education!"



SUJATHA DUVVURI

Founder and CEO of She Made Foods, in Mumbai, India

Years at Schoolcraft: 1996-1997

Course of study: Schoolcraft College International student who transferred to the University of Michigan, where she earned Bachelor of Arts degree in Economics.

"Schoolcraft College set the stage for my success in life. Professor Howie challenged me, and I have such fond memories of every class." Sujatha Duvvuri, founder and CEO of She Made Foods, exemplifies a confident leader. Each day, she meets with members of her team across a wide variety of disciplines in operations and business strategy/development to solve any issues and keep this maker of healthy and gluten-free food brands on track.

This confidence had its start at Schoolcraft College.

"Schoolcraft College was a big boost for my confidence level as a student," Ms. Sujatha said. "Since the class sizes were small, the personalized teaching and attention from the professors was everything a student needed to succeed.

"My Economics classes with Professor Cedric Howie challenged me the most and made me perform better as a learner and student. He brought out the best in me. Taking his courses and doing well in his class gave me the confidence to apply to the University of Michigan, NYU, and UC Berkley as a transfer student."

The results are apparent as She Made Foods continues to expand, with new markets in the Middle East and North America coming next. The business model is based mostly on e-commerce, plus sales in gourmet grocery chains throughout India, promoted on Twitter, Instagram and Facebook.

It's a bright future, one that Ms. Sujatha says others can attain as well.

"Enjoy the courses you are taking and engage with your professors," she said. "They are always there to help you, develop you, and enhance your capabilities. Dream big and work towards achieving your goals. If I could do it being an immigrant and an international student, anyone can!"



SHAWN J. LOVING

Executive Chef, Detroit Athletic Club

Years at Schoolcraft: 1989-1991 student; 2002-2007 instructor; 2007-2021 Department Chair, Culinary Arts

Course of study: Associate of Applied Science, Culinary Arts

"Picking and choosing [what you learn] in this craft will leave you in the lower tier, and you can't see from down there. Strive for wanting more." Shawn J. Loving, one of only 72 Certified Master Chefs in the world, made a tremendous contribution to Schoolcraft College first as a student, then notably as Department Chair for Culinary Arts for more than a decade.

Only a position as prestigious as Executive Chef at the Detroit Athletic Club, which he accepted in January of this year, could lure him away from his beloved Schoolcraft.

"Schoolcraft polished me for the real world," he said. "If you want to have practical learning so that you're rooted in gaining high-performance moments, then that is the help you receive at Schoolcraft."

Chef Loving is well-known and well-respected for his role as Executive Chef for the U.S. Men's and Women's Olympic Basketball Teams for the Beijing Summer Olympic Games in 2008 as well as the men's basketball team in Istanbul for the 2010 and 2015 FIBA World Championships, the 2014 summer World Championships in Madrid, and the 2016 Summer Olympic Games in Rio de Janeiro.

Last summer, he was asked to support the culinary efforts in the NBA's "bubble" in Orlando, Florida.

No matter the event, venue or audience, Chef Loving is meticulous and dedicated toward his craft. Everything – from oatmeal to a fine meal – earns his scrutiny.

"It becomes crucial to keep moving so there are not fires you can't tame," he said, explaining a "typical" day at the DAC. "Simple club sandwiches, deviled eggs, chili, and center-cut filet mignon all deserve focus and attention."

DR. PAUL DICKSON

Professor of Chemistry

Years at Schoolcraft: 2001-present

"I love seeing that spark of understanding and enthusiasm from students who understand a topic for the first time." Schoolcraft College faculty have become more creative, inventive and responsive in the face of the COVID-19 pandemic. These traits have helped students go from surviving (to finish the Winter 2020 semester) to thriving (in the new realities).

One example is the Chemistry 111 course, General Chemistry 1. It has the highest enrollment in the Chemistry Department, in part because it teaches most of the key principles students need to be successful in other Chemistry, Biology, Physics and Environmental Science courses.

To better help meet the needs of students who require this course, Dr. Paul Dickson, Professor of Chemistry, worked with the instructional team in Distance Learning to design it as a fully online course; it was piloted for the Winter 2021 semester.

"Every semester is a bit of a clean slate and so you get to try new things that you never thought of before," Dr. Dickson said. "My goal each semester is to try to improve the course from the last time I taught it."

Higher-level courses, such as Chemistry 117 (General Chemistry 2 & Qualitative Analysis), highlight the hands-on experience Schoolcraft College is known for. In this class, students "run the lab" under supervision.

"My favorite course to teach is CHEM 117," Dr. Dickson said. "I often hear how the students feel like real chemists during this time."



ELAINE MALAFOURIS

Adjunct Professor, Early Childhood Education/Special Education Department

Years at Schoolcraft: 2003-present

"I enjoy the students most of all. I love to watch them grow and develop their skills in their work with young children." Elaine Malafouris personifies the values Schoolcraft College faculty members pride themselves on: An accomplished professional eager to broaden their students' education beyond textbooks by sharing real-world knowledge and experience.

In her role as an Adjunct Professor in the Early Childhood Education/Special Education Department, Elaine teaches courses focused on how to set up and run before and after care programs for children and how to run an Early Childhood Program. She especially enjoys teaching the field experience courses.

But for Elaine, it is not only what she teaches, but how she teaches. She takes a personal interest in each student's success and is dedicated to supporting their educational and professional goals.

If, for example, a student is absent, you can bet Elaine will contact them to make sure everything is OK and to offer additional assistance and resources. Elaine has high expectations for her students and helps them to succeed.

"The students really inspire me to excel," Elaine said. "We have great students and because of them, I strive to do my best. I share my years of experience and knowledge so that they can become good teachers of young children."

The COVID-19 pandemic has underscored just how vital excellent child care is to parents and children. The next generation of professionals in this important field is needed now more than ever.

The graduates from Schoolcraft College will be ready to assume those positions – especially if they follow Elaine's simple but effective advice:

"Do the work, complete all assignments, ask for help when needed and have fun!"



KATHY STEGBAUER

Professor of Nursing

Years at Schoolcraft: 2004-present

"Schoolcraft College provides an educational opportunity to working adults that is inclusive and welcoming. There truly is a sense of belonging here on campus." Colleagues recognize Kathy Stegbauer, MSN*, RN, Professor of Nursing, as a pioneer in creating alternate clinical opportunities for our pediatric nursing students. That dedication has defined her career at Schoolcraft College, which began with teaching pediatric nursing clinicals in 2004. Today she teaches the theory and clinical pediatric portions of obstetrics/pediatric courses.

As with many of our instructors, her students inspire Stegbauer to excel.

"It inspires me that knowing that when students complete our program it not only changes their life, but their families and communities lives as well," she said. "My students' success motivates me to keep current and continually strive to explore what I can do to better prepare students for their nursing careers."

Pediatric nursing can be a difficult specialty in what's an already-demanding profession. But Stegbauer is determined to help her students meet that challenge. The quote "A challenge is a positive change in action" especially resonates with her.

"Nursing school is hard, and it should be hard!" she said. "You really don't want a nurse taking care of you or your loved ones that wasn't challenged. We as nursing faculty know that if you are successful in our program, we have done our job to prepare you for this awesome profession of nursing. And you cannot doubt that was a positive change!"

MANUFACTURING & ENGINEERING CENTER

Opened in the fall of 2020, the Manufacturing & Engineering Center is a 48,000-square-foot facility in the heart of Livonia's industrial corridor that is the new home for the College's engineering and technology programs.

Dean of Occupational Programs & Economic Development The Manufacturing & Engineering Center (MEC) is an excellent example of Schoolcraft College's proactive approach to better serve students, business and industry and the community at large.

The new facility more than doubled the space for occupational programs, including Biomedical Engineering Technology; Computer Aided Design (CAD); Engineering Technology; Electronics; Manufacturing Technology/ CNC (Computer Numerical Control); Mechatronics; Metallurgy and Materials Science; Plastic Technology; and Welding, that previously were in the Applied Sciences building. MEC also houses a 3D printing lab and robotics lab.

In addition to adding more hands-on space, with 26 classrooms/labs, the unique configuration of the MEC facilitates interactions between programs.

"For example, we have Metallurgy and Materials Science next to Welding because metallurgy is fundamental knowledge for good welders," said Dr. Robert Leadley, Dean of Occupational Programs & Economic Development.

"In many cases, the layout of the labs and classrooms for the various programs in MEC mirrors how professionals in those disciplines interact and collaborate in an industrial or manufacturing facility."

This type of real-world training is urgently needed because many occupations are seeing a shortage in talent because of retirements. Schoolcraft College and the MEC will help fill that pipeline with opportunities for apprenticeships, dual enrollment and workforce development courses.















Course of study: Pursuing Associate of Arts degree with plans to attend law school

"Don't be afraid of what other people think. Be whoever you are and let your star shine bright." For Lex Doty, Schoolcraft College has been a place where she could grow, explore, discover and challenge herself – in the classroom and beyond.

Lex had been out of school for a bit, then started going to college tours with her sister, including one at Schoolcraft. She found the atmosphere welcoming, which was especially important.

Lex took advantage of the many activities Schoolcraft offers, including Theater and Improv Club, Phi Theta Kappa, Business Club, Math & Physics Club, Safe Place and Board Game Knights to name just a few.

"I have had bosses and career counselors who made me feel valuable and helped me shift my focus from my weaknesses to my strengths," she said. "I have also made so many friends, including professors, faculty, and even other students who have helped me learn about who I am, who I can be, and to just let go of the fear and self-consciousness that held me back from so much in the past."



RONNI JADE SCALES

Course of study: Nursing

"Who knew this could be me? ANYTHING is possible. I knew I would be who I am meant to be! It's never easy but it is so worth it." Persistence and perseverance are just two of the words professors use to describe Ronni Jade Scales. Others that apply include determined, passionate and role model.

Scales has faced many obstacles in her life, including losing a parent and multiple family members. A single parent, she adeptly juggles caring for her children, work and schoolwork.

That challenge became even more difficult in the face of COVID-19 as she had to supervise her children's remote learning at the same time as of one her classes.

Course of study: Dual Enrollment Student

"Be yourself and strive to continuously grow – there is always something better or more 'lean', and you can be the next one to create something technologically advancing for our society." Rahul Madan is a great example of a student introduced to Schoolcraft College at an early age through Kids on Campus, then explored several offerings to build his future.

As a senior at Novi High School, he took advantage of Dual Enrollment, which allows high school students to earn college credit, to take courses in Supply Chain Management, one of the College's newest programs.

Already an established entrepreneur, Madan plans to attend Michigan State University and then pursue a career in business.

"Getting the opportunity to learn what supply chain is really about will help me determine whether I would like to pursue it as a career in the future," he said.

Madan said being able to advance his education with courses related to his interests has been a huge benefit.

"Taking this intro class is beneficial to me getting a grasp of what it's all about," he said. "We're going through the many aspects of supply chain and we work together as groups and how to essentially have the best ROI for our business based on all of our individual decisions in purchasing, operations, sales and finance."

Following your passion is something he encourages other Schoolcraft College students – or potential students – to do as well.

The Veterans Resource Center has additional funding opportunities that provide short-term assistance to military affiliated students demonstrating financial need that may be a barrier to their education. Funding is available through:

- The Veterans in Manufacturing Assistance Fund.
- The Mason's Veteran Retention Assistance Fund.
- The Veterans and Military Services Resource Center Fund.

With these funds, the VRC has been able to provide textbooks, laptops and other various aid to our students.

Small businesses who were able to supply personal protection equipment to governments were also supported through the contracting process. Training programs were transitioned to virtual programs based on the needs and requests of clients.

"My goal was and is to have hands-on experience for what engineers do on a daily basis, and AUCH has graciously provided a means for that to happen," Peper said.

AUCH has been an important partner for the College. In addition to the St. Joe's Mercy Elite Sports Center and the Sports Dome, AUCH's other projects for Schoolcraft include:

- · The Manufacturing & Engineering Center in Livonia, home to the College's occupational programs
- · The Public Safety Training Complex in Livonia, home to the College's police and fire academies
- Numerous renovations of rooms and space in buildings across the main campus

The transformation of Applied Science, which formerly housed the occupational programs, to the Health Sciences Center is the next key project for the College. The HSC will be the future home of all programs related to healthcare.

"Most of my experience has been gained through observing and participating in the process of renovating the Applied Science building," Peper said. "Many of my day-to-day tasks range anywhere from cleaning up the building and surrounding areas to reflect an efficient, orderly and well-managed project site; preparing areas to be worked in by other tradesmen; and assisting foremen of various subcontractors in completing one-off tasks."

The AUCH team was glad to have Peper.

"We were delighted that Will was the recipient of the AUCH Construction Scholarship and can now take it a step further with some real-life work experience in an effort to guide him with his goals for a potential future career in our industry," said Jeffrey D.
